- 3. You believe the Materials and the features and elements contained therein are unique, original and novel. However, you acknowledge and agree that: (a) other persons (including SKYFOX employees, independent contractors, licensees or third parties) may have submitted to SKYFOX, or to others, or made public, or may hereafter originate and submit, or make public, similar or identical material which SKYFOX may have the right to use; (b) the Materials may embody materials, suggestions or ideas substantially similar to those which have been developed by SKYFOX's employees, independent contractors or licensees, or which have been submitted to SKYFOX by others; and (c) you will not be entitled to any compensation because of SKYFOX's use of such other similar or identical material.
- 4. You confirm that you have retained a copy of the Materials submitted to SKYFOX and agree that SKYFOX shall not have any obligation to return the Materials, or any responsibility, financial or otherwise, for loss or damage to the Materials. You authorize SKYFOX to make such additional copies of the Materials as may be required for internal use in connection with SKYFOX's consideration of the Materials.
- 5. You hereby release and indemnify SKYFOX from any and all liability, claims, and demands, causes of action, related to the Materials, including without limitation, claims and demands and causes of action related to unfair competition, copyright infringement, breach of implied contract and breach of confidentiality and for loss or damage to the Materials.
- 6. You acknowledge and agree that if you have any claim of whatsoever nature against SKYFOX, you will be limited to your remedy at law for damages, if any, and you will not have the right to enjoin or restrain the development, production, distribution, advertising, publicizing or other exploitation of any product, production or materials owned or controlled by SKYFOX.
- 7. You acknowledge that you have received, or been given reasonable opportunity to receive, independent legal advice in respect of this Release.

Any change to, or waiver of, this Release must be in writing and signed by both parties. The invalidity of any provision of this Release shall not affect the remaining provisions. This Release applies equally to any other material which you may hereafter submit to SKYFOX unless agreed by us in writing to the contrary. This

Release is governed by the laws of the Province of Ontario and the parties irrevocably attorney to the exclusive jurisdiction of the courts of the Province of Ontario and the federal courts located therein. Any reference to SKYFOX shall be deemed also to refer to SKYFOX's subsidiary, parent and affiliated corporations, companies under common ownership or control with SKYFOX, and each of their directors, officers, agents, employees, licensees, successors and assigns.
